The Quality Coordinator functions in a support role to all other departments. The successful candidate will be working within a team environment to ensure all aspects of production are completed on time and meet the necessary quality standards. The Quality Coordinator will also work with the Corporate Quality Manager in the creation and control of documents supporting the QMS used by all Bailey Metal Products' branches.

- In-process testing of all products and processes to ensure continued adherence to established quality standards.
- Training of all staff in quality related processes and procedures.
- Support and verification of all quality-related processes:
  - Incoming inspection and establishing traceability (Receiving).
  - In-process inspection (packaging, labelling, adherence to product specification).
  - Monitoring of stock product raw materials and finished goods. (Warehousing).
  - Final inspection (Shipping).
- Control and maintain all inspection, measuring and test equipment.
- Maintain calibration of all test equipment on an ongoing basis.
- Creation of Internal Non-Conformance Reports.
- Control of returns from Customers including managing the RMA process.
- Training production/plant associates on new or improved quality processes, both one-on-one and in a group setting.
- Act as the point person for external audits such as CSSBI 61 certification.
- Organize the Joint Health & Safety Committee meetings (plan, take and distribute minutes, liaise with Corporate Health & Safety
  Manager as applicable)
- Manager as applicable).
- Take direction from the Corporate Quality Manager to develop forms, manuals, instructions, standard operating procedures, Quality Alerts, etc. to support both the Corporate Quality Management System, and the Corporate Operations Team as a whole.
